

1.	<p>Treatment & Condition</p> <p>Rucaparib for maintenance treatment of relapsed platinum-sensitive ovarian, fallopian tube or peritoneal cancer.</p>
2.	<p>Associated appraisal body & Summary of ruling</p> <p>NICE Technology Appraisal guidance TA611 (November 2019)</p> <p>Rucaparib (Rubraca[®]) is recommended for use within the Cancer Drugs Fund as an option for maintenance treatment of relapsed platinum-sensitive high-grade epithelial ovarian, fallopian tube or primary peritoneal cancer that has responded to platinum-based chemotherapy in adults, only if the conditions in the managed access agreement for rucaparib are followed.</p>
3.	<p>Number of people in Northern Ireland expected to take up service/therapy</p> <p>It is estimated that around 40 people per year with platinum-sensitive epithelial ovarian fallopian tube or peritoneal cancer that has responded to platinum-based chemotherapy are eligible for treatment with rucaparib.</p>
4.	<p>Patient Access Scheme Availability</p> <p>(Yes/No)</p> <p>The company (Clovis Oncology) has a managed access agreement, which includes a commercial arrangement, for rucaparib. The financial terms of the agreement are commercial in confidence.</p> <p>HSC Trusts will be required to claim all relevant reimbursements or discounts that form part of the managed access agreement.</p>
5.	<p>Infrastructure Requirements</p> <p>Any additional infrastructure costs associated with the introduction of new cancer therapies will be dealt with as part of the routine commissioning process.</p>
6.	<p>Expected implementation period</p> <p>There is no impediment to immediate implementation for new patients.</p>
7.	<p>Commissioning arrangements</p> <p>This regimen will be formally commissioned by the HSCB/PHA via the Specialist Services Commissioning Team initially on a cost-per-case (CPC) basis for as long as NICE indicates that funding via the Cancer Drugs Fund is appropriate.</p>

<p>8.</p>	<p>Monitoring arrangements</p> <p>The HSCB cost per case process will generate quarterly reports on the number of applications.</p> <p>HSCB currently routinely reviews quarterly monitoring information in relation to the usage of all recurrently funded specialist cancer drugs across both the Cancer Centre and other Units.</p> <p>The monitoring pro forma will be adapted to capture information in respect of this regimen and this group of patients. This monitoring report is submitted to the Specialist Services Commissioning Team for formal review and comment by the Team.</p> <p>Numbers of patients who received or are receiving treatment by the HSC Board and reported to the Department of Health.</p>
