## **Code of Conduct and Accountability: Declaration of LCG Members' Interests**

The Code of Conduct and Code of Accountability (1994) stated that high standards of corporate and personal conduct, based on public service values, must be at the heart of Health and Social Care organisations.

The Code of Conduct and Code of Accountability requires the Chair and Members of the HSC Board (HSCB), and the Chair and Committee Members of Local Commissioning Groups (LCGs) to declare interests which are relevant and material to the HSCB.

The declaration of LCG Members' interests shall be recorded in the minutes of the LCG meeting and the Register established shall be available at each public LCG meeting. Any future changes in Members' interests shall be reported to the Southern Commissioning Lead and declared at the subsequent LCG Meeting.
